## Paranormal Investigation Agreement and Authorization

Northern Lights Paranormal (NLP) is a team of paranormal investigators and researchers originating from Alaska. One of our primary purposes is documenting claims of paranormal activity using scientific methods. Conducting field research and gathering evidence is important to investigating occurrences of paranormal phenomena. We are seeking opportunities to advance the field of paranormal research as an acceptable scientific endeavour. Your cooperation is needed and appreciated.

The evidence we collect is gathered using ordinary electronic equipment (digital thermometers, audio recorders, video recorders). Collected evidence is joint ownership between NLP and you, our client. This joint ownership helps protect you and us from having any information that may be publicly released from being exploited or misrepresented. Evidence will be held within our organization for safekeeping, unless agreed upon otherwise. You will be provided a report of any findings and copies of any evidence.

Scientific documentation is a responsibility NLP takes seriously. We will never sensationalize evidence or make unscientific claims, including a conclusion that a property is haunted or not. Our duty is to take due care in reporting of any results, especially to the media. We respect your right to privacy and we will never share any information without your specific consent. All information is kept confidential unless agreed upon otherwise, as indicated below.

Our responsibility also extends to not conducting an investigation in any way which may cause our client to feel any presence exacerbated. NLP will never perform any clearance, cleansing, exorcism, removal, or other such ceremonies or rituals. If a more spiritual solution is desired by you, we can make a referral to an appropriate individual or organization.

We understand, and fully respect, that we will be on private property at all times. We will immediately terminate any investigation at any time for any reason, if so requested.

**Please indicate the level of confidentiality you desire:**

- NLP may not release any part of the investigation to the public or to anyone not directly associated with NLP.

- NLP may only share investigation data and results with other paranormal researchers provided no personally identifying information is exchanged.

- NLP may share investigation results with the public or media provided no direct identification of the witnesses, client or location is made.

- NLP may share all investigation data, including personally identifying information, with other paranormal researchers only. No information may be released to the public or media.  
Most Public Most Private *This option is non-confidential*
  
- NLP may share and release any and/or all information and/or evidence collected during the investigation.  
Most Public Most Private *This is the least confidential option*
